

## **CITY OF TEMPLE CITY CITY COUNCIL MEETING ACTIONS**

These are some of the City Council actions from their meetings of June 16, 2020. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the special meeting of June 16, 2020, the City Council:

- Met in closed session regarding 1 item of “Anticipated Litigation” and received a briefing from the City Attorney. There is no reportable action.

At the regular meeting of June 16, 2020, the City Council:

- Approved the minutes of the Regular City Council Meeting of June 2, 2020 and Special City Council Meeting of June 4, 2020;
- Received and filed the Planning Commission meeting actions of May 26, 2020;
- Approved the Amendment No. 3 – Support Services Agreement with the City of Brea/BreaIT for the period of July 1, 2020 to June 30, 2021 and authorized the City Manager to execute the Agreement;
- Received and filed an update on the status of the fireworks sales permits and on staff’s proposed course of action for future permits;
- Received and filed the Visa Card Report;
- Adopted resolution authorizing the payment of bills for Fiscal Year 2019-20;
- Adopted Resolution No. 20-5477 adopting the threshold of significance for reviewing traffic impacts of projects in compliance with the California Environmental Quality Act (CEQA) , directed staff to retain level of service analysis in project analysis to ensure consistency with the General Plan, and finds that that adoption of the new CEQA thresholds of significance are exempt from CEQA;
- Received and filed the Budget Study Session follow up;
- Allocated 40% of the Community Development Block Grant (CDBG) funds, received from the Coronavirus Aid, Relief, and Economic Security (CARES) Act to the Temporary Rental Assistance Program and 60% of funds to Small Business Association Program. Both programs are to be implemented on July 1, 2020. Council also approved to reduce the youth scholarship, housing rehab, and asbestos programs per staff’s recommendation;
- Received and filed the draft COVID-19 Economic Recovery Plan and provided staff direction for the final plan; and
- Received an update from City Manager and City Attorney; and
- Received reporting out from Council for items separate from the City Manager’s regular agenda.
