Three seats on the Planning Commission, which has decision-making authority on a variety of development proposals. Commissioners advise on programs, policies and issues relating to planning, development and land use regulation. Interested candidates should be residents and qualified electors of the city at the time of their appointment to office and members shall be required to remain residents and qualified electors of the city during their entire period of service on the commission. The Commission meets on the 2nd and 4th Tuesdays of the month at 7:30 p.m.

Three seats on the Transportation and Public Safety Commission, which makes decisions on administrative and parking citations, and develops recommendations regarding the administration of public safety programs. Interested candidates should be residents and qualified electors of the city at the time of their appointment to office and members shall be required to remain residents and qualified electors of the city during their entire period of service on the commission. The Commission meets on the 2nd and 4th Wednesday of the month at 7:30 p.m.

Three seats on the Parks and Recreation Commission, which makes recommendations on the development and oversight of the City’s parks facilities and recreational programming. Interested candidates should be residents and qualified electors of the city at the time of their appointment to office and members shall be required to remain residents and qualified electors of the city during their entire period of service on the commission. The Commission meets on the 3rd Wednesday of the month at 7:30 p.m.

The City Council will select Commissioners through an interview process. Those selected will serve a two year term. The City covers costs for training and conferences as resources allow.
