These are some of the City Council actions from their meeting of June 15, 2021. This is an unofficial record of the City Council meeting. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meeting.

At the regular meeting of June 15, 2021, the City Council:

- Approved Minutes of the Special City Council Meeting of May 26, 2021;

- Received and filed the Parks and Recreation Commission Regular Meeting Actions of May 19, 2021;
- Adopted Resolution No. 21-5527 confirming appointments of Lance Baroldi, Joanne Rosso and Cynthia Vance to the Parks and Recreation Commission with terms ending June 30, 2023; adopted Resolution No. 21-5528 confirming appointments of John Cordes, Beverly Guan and Jeffrey Lee to the Planning Commission with terms ending June 30, 2023; and adopted Resolution No. 21-5529 confirming appointments of Joel Catalan, Michael Stoll and Jeffrey Xu to the Transportation and Public Safety Commission with terms ending June 30, 2023;
- Reviewed and approved the final subdivision map for Parcel Map No. 74527 and authorized the City Clerk to certify Parcel Map No. 74527;
- Approved Resolution 21-5537 to approve the resurfacing of various streets citywide as Temple City's designated project for RMRA funds for Fiscal Year (FY) 2021-22 pursuant to Senate Bill 1, the Road Repair and Accountability Act of 2017 (SB 1); directed the City Manager to include the corresponding Capital Improvement Projects (CIPs) in the FY 2021-22 City Budget including RMRA funds and the required General Fund maintenance of effort match; and authorized the City Manager to submit the required documents and information to the California Transportation Commission for the City to receive RMRA funds;
- Adopted Resolution No. 21-5533 adopting the Statement of Investment Policy for FY 2021-22;
- Received and filed the Visa Card Report;
- Adopted Resolution No. 21-5538 approving payment of bills for Fiscal Year 2020-21;
- Adopted Resolution No. 21-5535 approving the Master Fee and Fine Schedule for Fiscal Year 2021-22;
- Adopted Resolution No. 21-5534 adopting the annual Appropriations Limit for Fiscal Year 2021-22;
- Adopted Resolution No. 21-5536 adopting the city budget for Fiscal Year 2021-22 without the rebate for trash collection service;
- Approved the annual rate adjustment requested by Athens Services for solid waste collection services to become effective July 1, 2021;
- Received updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
