CITY COUNCIL MEETING ACTIONS**

These are some of the City Council actions from their meetings of March 15, 2022. This is an unofficial record of the City Council meetings. The Minutes, once approved by the City Council at a subsequent meeting, become the official record of the meetings.

At the Regular meeting of March 15, 2022, the City Council:

- City Clerk Kuo administered the Oath of Office to re-elected Councilmembers Tom Chavez and Vincent Yu;
- Received an update from the Youth Committee;
- Approved the Minutes of the Regular City Council Meeting of March 1, 2022;
- Approved the Minutes of the Special City Council Meeting of March 8, 2022;
- Received and filed the actions of the Planning Commission's Regular Meeting of February 22, 2022;
- Adopted Ordinance No. 22-1060 adding Section 2-1-9 "Campaign Contribution Regulations" to Chapter 1 "City Council", Title 2 "Administration";
- Adopted Resolution No. 22-5588 adopting the City's amended Records Retention Schedule;
- Received and approved the 2021 General Plan Annual Progress Report and directed staff to file the report with the Office of Planning and Research and the Department of Housing and Community Development;
- Received and filed the Visa Card Report;
- Adopted Resolution No. 22-5587 approving payment of bills for Fiscal Year 2021-22;
- Received the Fiscal Year 2021-2022 Mid-Year Financial Review and related reports and approved and authorized staff to revise revenue estimates as indicated in Attachment A of the staff report;
- Received and filed the Annual Comprehensive Financial Report (ACFR) for the year ended June 30, 2021, received and filed Independent Auditor's Communication to the City, received and filed the Independent Accountants' Report on Applying Agreed-Upon Procedures Related to the Article XIII-B Appropriations Limit Calculation (Gann Limit), and received and filed the Independent Auditor's Report on Internal Control over Financial Reporting and on Compliance and Other Matters Based on an Audit of Financial Statements Performed in accordance with Government Auditing Standards;
- Established the Commissioner Recruitment Ad Hoc Committee and appointed Councilmember and Councilmember to the committee;
- Received updates from the City Attorney and City Manager; and
- Received Councilmember reports on items separate from the meeting agenda.
